## **Lilley Lovett Theatre Group Trial Session Terms and Conditions**

- Trial sessions are charged at £3.75 per hour which must be paid in advance by bank transfer (Sort Code: 09-01-26, Account Number: 84072808, Account Name: Ruth Lilley)
- If, following the trial sessions, your child decides to join the Lilley Lovett Theatre Group, membership fees will be calculated on a pro-rata basis for the remainder of the term. Membership fees are charged at a rate of £8.00 per hour with additional younger siblings being charged at £4.80 per hour.
- Full Membership of the Lilley Lovett Theatre Group will be allocated on a first come, first served basis on receipt of a signed enrolment form and the appropriate payment.
- Children should not bring valuables to sessions. The Lilley Lovett Theatre Group cannot be held responsible for any loss or damage to personal belongings whilst attending our activities.
- Children participate in sessions at their own risk and parents must inform us of any existing injuries or medical conditions. The Lilley Lovett Theatre Group cannot be held responsible for any injury caused whilst participating in our activities.
- If your child is unwell or has an accident requiring emergency treatment, you will be contacted via the main or emergency contact details provided. This number must always be contactable whilst your child is attending a session. If we are unable to contact anyone on the numbers provided, your child will be given whatever medical attention is deemed appropriate, including being transported to hospital if necessary.
